

THE CORPORATION OF THE TOWN OF WASAGA BEACH

BY-LAW NO. 2026-16

A By-law to amend the Town of Wasaga Beach System of Administrative Monetary Penalties - Non-Parking (2025-18)

WHEREAS section 5(3) and section 434.1 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, authorize a municipality to exercise its powers by by-law and to establish a system of administrative penalties for contraventions of its by-laws;

AND WHEREAS the Council of the Town of Wasaga Beach enacted By-law 2025-18, being the Administrative Monetary Penalties By-law – Non-Parking, as amended, to provide for the administration and enforcement of administrative monetary penalties for designated by-laws;

AND WHEREAS the Council of The Corporation of the Town of Wasaga Beach enacted By-law 2025-63, being the Municipal Accommodation Tax By-law, to establish and govern the collection and remittance of a municipal accommodation tax within the municipality;

AND WHEREAS the Council of The Corporation of the Town of Wasaga Beach enacted By-law 2026-08, being the Short Term Accommodation By-law, to regulate short term accommodation operations within the municipality;

AND WHEREAS Council deems it necessary and desirable to amend the Administrative Monetary Penalties By-law to update Schedule “A” – Designated By-laws and Administrative Penalties, to include administrative penalties for contraventions of By-law 2025-63, as amended, and By-law 2026-08, as amended;

AND WHEREAS Council of the Town of Wasaga Beach deems it necessary and desirable to include these by-laws into the Administrative Monetary Penalties framework to provide the authority to address non-compliance, promote compliance, and apply enforceable administrative penalties where required;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF WASAGA BEACH HEREBY ENACTS AS FOLLOWS:

1. **THAT** Schedule A, Designated By-laws and Administrative Penalties is hereby amended by adding the following:

8. **Municipal Accommodation Tax By-law**

For the purposes of Section 8.1 of this By-law:

- (a) Column 1 in Table 1 lists the provisions in the **Town's** Municipal Accommodation Tax By-law 2025-63, as amended, that are hereby designated for the purposes of Section 434.1 of the **Municipal Act**;
- (b) Column 2 in Table 1 sets out the short form wording to be used in a **Penalty Notice** for the contravention of the designated provisions listed in Column 1;
- (c) Column 3 in Table 1 sets out the **Administrative Penalty** amounts that are payable by a **Person** excluding a **corporation** for a contravention of the designated provisions listed in Column 1 of the **Town's** Municipal Accommodation Tax By-law 2025-63, as amended.

2. **THAT** Schedule A, Designated By-laws and Administrative Penalties is hereby amended by adding the following:

9. Short Term Accommodation By-law

For the purposes of Section 14.2 of this By-law:

- (a) Column 1 in Table 1 lists the provisions in the **Town's** Short Term Accommodation By-law 2026-08, as amended, that are hereby designated for the purposes of Section 434.1 of the **Municipal Act**;
- (b) Column 2 in Table 1 sets out the short form wording to be used in a **Penalty Notice** for the contravention of the designated provisions listed in Column 1;

- (c) Column 3 in Table 1 sets out the **Administrative Penalty** amounts that are payable by a **Person** excluding a **corporation** for a contravention of the designated provisions listed in Column 1 of the **Town's Short Term Accommodation By-law 2026-08**, as amended.
